Living the Cooperative Principles

Cooperatives are a unique form of business enterprise in that the consumers of the services also have ownership in the organization. This ownership is through the form of patronage, which is similar to owning stock in a private corporation, but there are differences. Cooperatives have a different focus than private businesses and this focus is represented in the seven cooperative principles – 1) voluntary and open membership, 2) democratic member control, 3) member's economic participation, 4) autonomy and independence, 5) education, training and information, 6) cooperation among cooperatives and 7) concern for community.

Every year, the Board of Directors of REC, meet to review applications for a range of scholarships offered by REC for post high school education. These scholarships include a full four-year academic scholarship to Adams State University, several \$500 and \$1000 awards, and a scholarship for lineman training. These scholarships represent REC's commitment to two of the cooperative principles – 5) education, training and information and 7) concern for community.

In addition to the scholarship program, REC has started an internship program to expand its efforts for these cooperative principles. The first internship that started late last year focused on engineering. In 2016, Emily Novotny received the Villyard scholarship, a \$1000 scholarship, supporting her enrollment at Colorado School of Mines in engineering. I had a chance to meet Emily at the 2016 REC annual meeting which lead to her accepting the engineering internship with REC. This internship will provide valuable industry experience to Emily as she completes her engineering education.

The internship program also supports REC in many ways. It provides a path to future employees, though that is always dependent on the goals of the intern and the needs of REC. This engineering internship program also provides REC with access to current technical knowledge and engineering advances. Internships also build relationships with future generations helping to ensure that new generations know about electric cooperatives. While the first internship is focused on engineering, REC is considering a business internship in the future.

Along with these internships, the apprentice lineman program at REC provides a constant source of new linemen who bring new ideas to the way of building and maintaining REC's electric infrastructure. The apprentice lineman program and the internship program are challenging learning environments which provide both structured learning and on the job training. These programs are vital to the future success of REC. New ideas, new ways of thinking, and new approaches to problem solving combined with existing business processes keep our cooperative moving forward, improving efficiency, and effectiveness of that we do.

RECIPES OF THE MONTH

INGREDIENTS

4 cups strawberries, cleaned
1 tablespoon sugar
4 slices thick multigrain bread
1 tablespoon olive oil
½ large ripe avocado, sliced
2-4 slices Mozzarella slices

Summer up your sandwich!

Roasted Strawberry, Avocado and Mozzarella Grilled Cheese

Preheat oven to 375° F. Line a baking sheet with foil and lightly coat with nonstick cooking spray. In a medium bowl, toss strawberries with sugar so that they are fully coated. Transfer to prepared baking sheet and arrange so that they aren't crowded. Bake for 20 minutes or until berries are juicy.

Heat a skillet over medium high heat. Lightly brush or drizzle half of olive oil over two slices of bread and place oiled side down in a skillet. Lay mozzarella on top then add avocado and roasted strawberries. Drizzle two slices of bread with olive oil and place oiled side up on the sandwich.

Cover with a lid and cook about 4-5 minutes or until golden brown on bottom. Carefully flip the sandwich, reduce heat to medium and cook a few more minutes or until the bread is golden brown. Enjoy immediately! Makes 2 sandwiches.

Cherry Almond Dutch Baby

Heat oven to 425°F. Whisk egg, sugar, flour, milk, extract and salt together until the batter is blended but lumpy; you can also do this in a blender. In a 12-inch ovenproof frying pan, melt butter. Add cherries and cook until warmed, about 2 minutes. Pour in batter and transfer to heated oven. Bake for 15 to 20 minutes, until golden brown and rumpled-looking.

Remove pancake from oven and quickly scatter with toasted almonds, dust with powdered sugar and squeeze lemon juice over. Serve in wedges, piping hot.



INGREDIENTS

3 large egg
2 tablespoons granulated sugar
3/4 cup all-purpose flour
3/4 cup milk
1/2 teaspoon almond extract (more or less to taste)
Pinch of salt
4 tablespoons butter
2 cups pitted sweet cherries
1/2 cup sliced almonds, well-toasted
Powdered sugar
Lemon wedges
